Highlights of the 86th IGAEA Conference



The 2011 Annual IGAEA Conference was held at the Eldorado Hotel and Casino in Reno on July 21-27. The hosts Tom and Carol Loch with the help of the IGAEA Board of Directors did an excellent job in organizing the conference. The IGAEA members were able to enjoy various presentations, network, and socialize. Guests were also able to enjoy various activities, such as sightseeing of the Carson City and Lake Tahoe, visiting the Art Museum, enjoying the Riverwalk Activities in Reno; and visiting the Nevada-Reno Planetarium and Nevada Historical Society Museum. The Treasurer's Trove

The 2010-11 academic year was a good one for IGAEA. We had a very effective, educational, and enjoyable conference in Reno...a conference that generated quite a bit of support from our industry partners and even returned some proceeds (about \$1,000) to the Association to be used to support the Bob Cox and Von Holtz Awards. Thanks to all who made the conference a success, both professionally and financially.

Fiscally, IGAEA ended the 2010-11 year on a fine footing. Our balance sheet, available at http://www.igaea.org/images/stories/Balance_Sheet.pdf, indicates that, on July 31, 2011, the Association had a total of \$116,617.22 in assets. These assets consisted of about \$75,000 in long-term investments and about \$42,000 in liquid assets. The end-of-year balance sheet does not, however, reflect payments we made in August to cover the costs of our 2011 Conference. Thus, as of this writing (September 26, 2011), the Association had \$93,200.23 in total assets.

If you are interested, you can read and/or download a Budget Summary Report and our Cash Flow report at http://www.igaea.org/International-Graphic-Arts-Education-Association/financial-documents.html. These documents outline how your funds were used during the year to support the Association's objectives. These documents, as well as required receipts and correspondence, have been shipped to our accountant, Lawrence Travis, so that he can prepare our 2010-11 audit.

During the 2011 Annual Meeting, the membership in attendance voted to increase our regular dues to \$50 and the associate (retired) dues to \$20. Those dues are reflected in the 2011-12 budget, which you can download at http://www.igaea.org/images/stories/IGAEA_2011-12_Approved_Budget.pdf. Note that the new dues are effective beginning in the 2012 calendar year. Thus, if you still haven't paid your 2011 calendar year dues, you will need to pay \$40 if you are a regular member or \$12 if you are retired.

Speaking of late dues, the Association has, for many years, charged a late fee of \$5.00 if you pay after the date indicated on your invoice. Please make sure that you--or your employer--include that additional fee if you pay late. Otherwise, we will have to send you another bill. Since we are an all-volunteer organization, we ask that you please pay your dues on time so that we do not have to spend additional time and money following up.
